## What qualifies a drug to require prior authorization

- Complex/specialized conditions
- High cost (exceeding \$950 month)
- Specialized Storge, handing or administration requirements
- Limited distribution (specialty pharmacy)
- Risk Evaluation and mitigation Strategy program Requirements
- Benefits outweigh risk

### How is a new drug classified

- Evidence-based medicine (EBM) principles to assess new drugs determines the appropriate drug list coding
- The route of administration and specialty care
- Clinical review of the therapeutic class
- P&T Committee meets regularly to review and approve best available evidence and medical practice.




