Date: January 7, 2022

We have submitted in December 2021, the ESSA Financial Transparency (Every Student Succeeds Act) report for fiscal year ending 6/30/21 as per Education Law section 3614. The report is still under review by SED. Upon acceptance of the report, we will present to the Board of Education and then post on the District website as per the reporting requirements we have followed with past filings of Transparency and ESSA reporting.

The objective of the report is to display building level expenditures. The report displays the General Fund expenditures along with Federal Grants and the School Lunch Fund. Transportation, Debt Service, Private and Charter school tuition and Summer Special Education costs are not part of the allocation for building level expenditures.

As of today we have submitted the following in compliance with NYS and Federal Education requirements:

*New York State School Funding Transparency Form 2021-2022 budget submitted and approved by Division of Budget and SED.*

*ESSA Financial Transparency report 2020-2021 expenditures submitted to SED in the business portal and in the review process.*

*The spending per student per school continues to be the highest at Lincoln at \$22,063 or a 6.78% from 2019/20. The Middle School continues to reflect the lowest spending at \$18,946 per student, an increase of 3.66%. The total spending continues to be the highest at the High School at \$10,923,000, an increase of 3.42% with the lowest total spending continuing at t Glendaal ES at \$2,831,000, an increase of 3.70%.*

Enrollment has decreased from the prior year by 54 students or 2.21% with the MS showing the greatest decline of 50 students and the High School the great increase at 27 students. Glen Worden ES had a decrease of 31 students from the prior year

District headcount increased by 13 with Teaching Assistants increasing by 3.35 fte, Teachers, 1.64 fte and Administration by 2 fte and Transportation 2 FTE and Mgmt. Confidential 1 fte.

I have attached a chart which displays in detail key categorical changes summarized in above.

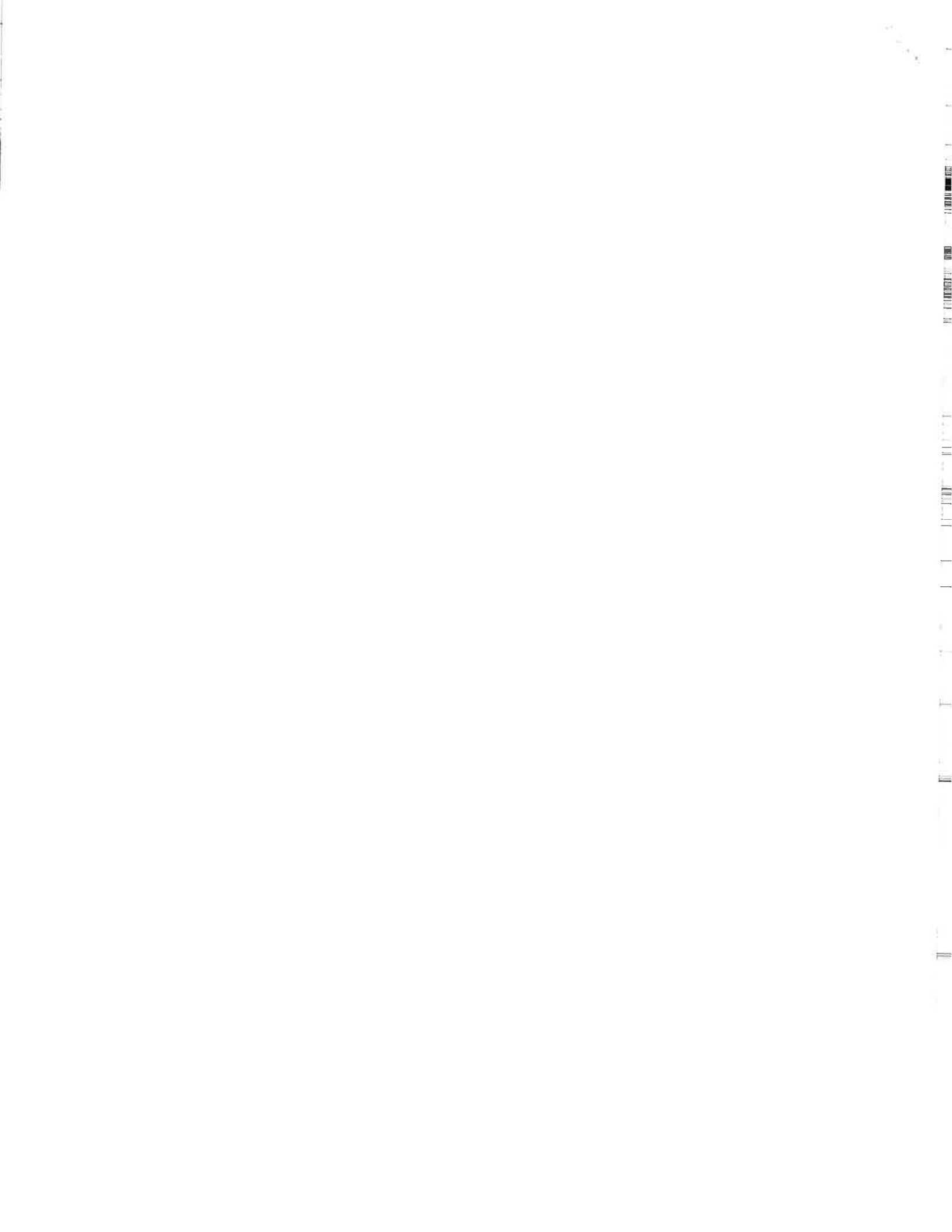
