

RULES AND REGULATIONS

1. Names and Purpose of Scholarship Fund:

The Scotia Rotary Foundation Pedrick, Peterson, and Hollenbeck Memorial Scholarship Award was established in 1990 to honor the memory of these three long-time, outstanding citizens of the Scotia-Glenville community. Each has made numerous contributions to the community and has placed service above self. The name of this scholarship may not be changed.

2. Sponsor and Administration of Fund:

The sponsor of this scholarship award will be the Scotia Rotary Club. Any changes in the terms or conditions of this scholarship award will be made subject to the approval of the Board and the terms of the Deed of Gift. The selection committee of the Scotia Rotary Club will be the only persons authorized to recommend disbursement of funds from this account.

3. Selection Committee:

The Selection Committee will consist of the Student Awards and Loans Committee of the Scotia Rotary Club. The recipient of this award will be chosen after the Scotia-Glenville Senior High School submits three to five names to the Selection Committee. The business conducted by this committee shall be by majority vote of the committee after careful review of the applications submitted by the school.

4. Value and Number of Scholarships:

There will be one scholarship award presented annually. The amount of this scholarship award will be based on income from the gift of \$30,000.00 as determined by the Selection Committee.

5. Criteria for Award:

The scholarship will be awarded on an annual basis to a member of the senior class in the Scotia-Glenville Senior High School upon graduation, who has exemplified the Rotary motto "Service Above Self." The applicant should also have demonstrated sound academic achievement, qualities of leadership, and an enjoyment of life. In addition, the candidate must be planning to further his or her education at a college or university and show a financial need for this scholarship in order to pursue that plan.

6. Application and Selection Procedures:

Each applicant is required to submit a letter describing why he or she meets the criteria for the award:

- Service to school
- Service to community
- Sound academic achievement
- Leadership
- Enjoyment of life
- Financial need

The Scotia-Glenville Senior High School will submit to Scotia Rotary the names of three to five applicants who best meet the criteria for selection. The Selection Committee (Student Awards and Loans Committee) will meet as necessary to decide on the recipient. An application form, available in the guidance office may be used and submitted with the candidate's letter. Application procedures should be published yearly in a timely and appropriate manner.

7. Payment of Award:

The recipient of the award will be presented the award at such time that Scotia Rotary and the Scotia-Glenville Board of Education (or its designee) deem appropriate.
