- The administrative component of a contingent budget shall not comprise a greater percentage of the contingent budget exclusive of the capital component than the lesser of the (1) the percentage the administrative component had comprised in the prior year budget exclusive of the capital component or 2) the percentage of the administrative component had comprised in the last proposed defeated budget exclusive of the capital component.
